You must sign your name on the **Statement** and return the statement using one of the following methods:

- Drop box: Submit the completed statement into a Registrar of Voters ballot drop box located in the 36th State Senate District or at the Registrar of Voters' office before 8:00 p.m. on Election Day

The signature you provide on your Signature Verification Statement may be added to your voter registration record to be used for signature comparison purposes in future elections.
