We have determined that the signature you provided on your vote-by-mail ballot envelope does not compare with the signature(s) on file in your voter record. To ensure that your vote-by-mail ballot will be eligible to be counted, the Signature Verification Statement must be completed and returned as soon as possible.

The enclosed Signature Verification Statement must be completed and received by the Registrar of Voters no later than 5:00 p.m. on March 4, 2025.

You must sign your name on the **Signature Verification Statement** and return the statement using one of the following methods:

- **Mail** to Orange County Registrar of Voters, 1300 S. Grand Ave, Bldg C, Santa Ana, CA 92705 or use the postage paid envelope enclosed
- **Deliver in-person or have delivered** to a Vote Center location in the 36th State Senate District before 8:00 p.m. on Election Day, or the Registrar of Voters' office by 5:00 p.m. on March 4, 2025. Vote Center locations can be found at ocvote.gov/votecenter

- Fax to the Registrar of Voters' office at (714) 567-7556 or (714) 333-4488
- Drop box: Submit the completed statement into a Registrar of Voters ballot drop box located in the 36th State Senate District or at the Registrar of Voters' office before 8:00 p.m. on Election Day

The signature you provide on your Signature Verification Statement may be added to your voter registration record to be used for signature comparison purposes in future elections.
