Dear Orange County Voter:

Thank you for being registered to vote so your voice can be heard regarding how your community is governed and by whom.

As your Registrar of Voters, it is my commitment that Orange County elections are fair, accurate, transparent, and accessible. This Voter Information Guide explains how, when and where to vote in the June 7, 2022 Statewide Direct Primary Election.

Please take a moment to review your options for voting safely and securely in this election:

- Mail Ballots: Pursuant to Elections Code section 3000.5, every voter must be mailed an official ballot. We will deliver ballots to the U.S. Postal Service on May 9th.
- Convenient Voting at Home: You can return your mail ballot at one of our secure ballot drop boxes, by mail (no postage required), or at one of our Vote Centers. See all of your options at ocvote.gov/options.*
- Vote Center Voting: We will operate more than 180 full-service Vote Centers throughout the county where you can vote in-person. Select locations open daily beginning May 28th and all Vote Centers will be open from June 4th through June 7th. You can vote at any location. For locations and hours visit ocvote.gov/votecenter.

Election Day is 11 Days. Vote early to avoid possible lines on June 7th.

We work hard to make voting convenient and safe for all Orange County voters. The Registrar of Voters website **ocvote.gov** includes maps to our Vote Centers and secure ballot drop boxes as well as wait times at open Vote Centers. You can also sign up to receive notifications to track your mail ballot with OC Ballot Express.

Note: A separate State Voter Information Guide will be mailed to you, which contains information about candidates for U.S. Senator and Statewide Constitutional offices

Can I vote if I register after the registration deadline?

Yes, conditional voter registration extends the 15-day registration deadline in California to eligible voters, allowing them to register and vote provisionally starting 14 days prior to an election and on Election Day, at the Registrar of Voters' office, located at 1300 S. Grand Ave., Bldq C, Santa Ana, 92705 or at any Vote Center.

Can I vote if I moved to another address in Orange County?

Yes, but you must register at your new address by the deadline above. You may vote and re-register at the:

- Registrar of Voters' office; or
- · Any Vote Center

To find out if you're registered, visit ocvote.gov/verify. To register online, visit: registertovote.ca.gov

Can I vote if I have not voted in the last 4 years?

RESIDENCE CONFIRMATION:

If you have not voted in any election within the preceding four years, and your residence address, name, or party preference was not updated during that time, you may need to confirm your residence address in order to remain on the active voter list and receive election materials in the mail.

Visit ocvote.gov/confirm to confirm your residency.



Voting assistance available at Vote Centers

Every effort has been made to ensure all Vote Centers meet accessibility standards. Vote Centers will feature:

- Accessible voting machines to mark your ballot
- American Sign Language interpreter via video conferencing
- Curbside voting with paper ballot
- Additional assistance upon request

Voters that are unable to mark a ballot may bring up to two individuals to assist in voting (§ 14282 (b)).

We will help voters with disabilities have a successful voting experience and identify issues we can address before the June 7 Statewide Direct Primary Election.

Vote-by-Mail

You can vote by mail before Election Day

Every voter in Orange County will receive a Vote-by-Mail ballot. You can mark your ballot and send it back by mail or drop it off at any Vote Center or ballot drop box. Vote-by-Mail ballots must be postmarked or delivered to a Vote Center or ballot drop box by **June 7**.

How to return your Vote-by-Mail ballot

Mark your ballot, then follow the instructions on the official envelope to sign and seal your ballot in the postage-paid envelope provided.

You can:

- Mail your ballot, so that it is postmarked by Election Day, June 7
- Drop off your ballot at any ballot drop box in Orange County. Visit ocvote.gov/dropbox for more information
- Drop off your ballot at any Vote Center in Orange County. Visit ocvote.gov/votecenter for more information
- Hand-deliver your ballot to the Orange County Registrar of Voters at:

If you are unable to return your ballot, you may use your Vote-by-Mail envelope to authorize someone you trust to return it for you.

If you drop off your ballot at a Vote Center, an employee will make sure your envelope is filled out correctly.

Remote Accessible Vote-by-Mail Ballot

Any voter may cast a ballot using a certified Remote Accessible Vote-by-Mail (RAVBM) system. The electronic ballot can be downloaded to the voter's computer, marked using the voter's own computer or assistive technology, then printed and returned by following the instructions included with the electronic ballot.

No later than seven days before Election Day, the voter may request the county elections official to send or deliver a ballot that voters with disabilities can read and mark privately and independently pursuant to the federal Help America Vote Act of 2002 (52 U.S.C. Sec. 20901 et seq.).

Replacement Ballots

If you need a replacement ballot, you can request one using the following methods:

- Online at ocvote.gov/replacement (available after ballots are mailed until 7 days before the election).
- Over the phone at 714-567-7600 (available after ballots are mailed until 7 days before the election).
- At any Vote Center during the in-person voting period (see hours and locations in this guide).

Please note: Vote-by-Mail ballots will be mailed beginning on May 9. Please allow adequate time for delivery.

Primary Elections in California

How do primaries work in California?

In a Primary Election, voters choose candidates to run in the General Election in November.

For the June 7, 2022 Statewide Direct Primary election, you will have Voter-Nominated and Nonpartisan contests on your ballot.

In a California Top-Two Primary, for offices nominated by the voters, you can vote for any candidate, no matter what your party preference is.

- All voters can vote in the Top-Two Primary.
- You can vote for any candidate or write in a candidate.
- A candidate's party preference is shown with his/her name. If a candidate is not registered with a party, his/her party preference is listed as "None."
- The Top Two vote-getters move on to the General Election in November. It is possible that the top two could be from the same party.

For state, county, or local offices in a Nonpartisan Primary, all voters can vote for any candidate.

- The candidates' party preference does not appear on the ballot.
- If a candidate receives 50% plus 1 vote in the Primary, that candidate is elected.
- If no candidate receives 50% plus 1 vote, the top two vote-getters go to a run-off at the November General Election, except for County Board of Education Member, where the top vote-getter is elected.

Why do we have a "Top-Two Primary"?

Proposition 14, passed by California voters on June 8, 2010, created the Top Two Candidates Open Primary Act. This act requires that the two candidates receiving the greatest number of votes in the Primary Election will appear on the General Election ballot regardless of party preference.



Language Voter Assistance

Section 4

State law required language assistance information

Translated reference ballots in Tagalog, Farsi (Persian), Hindi, Japanese, and Gujarati of eligible precincts will be available at all Vote Centers in Orange County. You may also cast a Vote-by-Mail ballot in person at a Vote Center. For hours and locations, turn to the Vote Center Locations section of this guide or visit **ocvote.gov/voting**.

No later than seven days before the day of the election, the voter may request a vote-by-mail ballot in Spanish, Vietnamese, Chinese or Korean, or a translated reference ballot in Tagalog, Farsi (Persian), Hindi, Japanese, or Gujarati for voters in eligible precincts.

Voters in eligible precincts may request a translated reference ballot through the included postage-paid postcard, or contact our office at:

Ang mga isinaling masasangguning balota sa Tagalog, Farsi (Persian), Hindi, Hapon, at Gujarati ng mga karapat-dapat na presinto ay makukuha sa lahat ng Sentro ng Pagboto sa County ng Orange. Maaari mo ring botohan ang isang balota ng Pagboto sa Pamamagitan ng Koreo nang personal sa isang Sentro ng Pagboto. 





I currently work with state, local, and federal partners to prosecute drug cartel members, doctors and pharmacies that divert controlled substances, gang members, and street-level fentanyl dealers. In 2020, I was awarded the "Excellence in the Pursuit of Justice Award" by the U.S. Attorney for the Southern District of California for my work in litigation involving controlled substances. When issuing the award, the U.S. Attorney noted that my leadership and the ruling I helped secure would "bear fruit for years in controlled substances investigations."

I believe that District Attorneys should avoid not only impropriety but also the appearance of impropriety. To ensure public confidence in the office and avoid even the appearance of impropriety in the minds of voters, I am forgoing political donations during this campaign.

I was raised in Orange County and know how special it is. I am running as a private citizen, not as a politician or government representative, because Orange County deserves a District Attorney with an unwavering focus on the best interests of its citizens. I would be humbled to receive your vote.

I am a former Orange County Deputy District Attorney with 30 years of experience as a prosecutor. If elected District Attorney, I will use my experience to ensure that the district attorney's office operates in a professional, ethical, and competent manner focused on the prosecution of criminal violations. While supervising the Felony Panel, I initiated a review of a series of sexual assault homicides that occurred in the late 1970s. The investigation led to the arrest of Gerald Parker and his conviction of 6 counts of murder. It also freed an innocent man who had been wrongly convicted of one of the offenses and had served 16 years in prison. After Parker was in custody, I organized and obtained funding from the state for an unsolved homicide project named TRACKRS. Thereafter, I initiated the Orange County Innocence Project. It involved providing O.C.D.A forms to all of the state's prison facilities for inmates who felt that they had been wrongly convicted.

The work of the District Attorney's Office is crucial to our system of justice. The power granted to deputy district attorneys must be carefully and fairly applied. Cases should be evaluated and prosecuted ethically without infringing upon defendants' rights. I have the experience and background to restore integrity and professionalism to the leadership of the District Attorney's Office. This is particularly necessary given the prevalent atmosphere of increased criminal conduct and violence that seems to be spreading across the country.

Impartial Analysis City of Huntington Beach Measure A

Measure A is submitted to the voters by the Huntington Beach City Council and would amend the Huntington Beach Municipal Code to establish a Cannabis Business Tax that would apply to commercial cannabis businesses that may operate in Huntington Beach, as defined in the proposed ordinance.

Background

On March 1, 2022, the Huntington Beach City Council approved submission of an ordinance for voter approval to amend the Huntington Beach Municipal Code ("HBMC") to establish a special tax that would apply to commercial cannabis businesses that may operate in Huntington Beach. The ordinance would establish both (i) a not-to-exceed rate of 6% local special tax on the gross receipts received by any cannabis retail business; and (ii) a not-to-exceed rate of 1% local special tax on any other cannabis business, including but not limited to indoor cultivation, manufacturing, testing laboratory, and distribution. The special tax must be approved by 2/3 of the voters in Huntington Beach, the proceeds of which would be deposited into a special City fund for police services for public safety, behavioral health and homeless prevention, and intervention programs and services. The special tax to be presented at a special election consolidated with the Statewide Primary Election in June of 2022.

The City Council cannot repeal this special tax, or set any adjusted rate that exceeds the maximum rates.

The Measure

If passed, Measure A would amend the HBMC to impose a special tax on commercial cannabis businesses as defined in the proposed ordinance. The tax would apply even if the business was operating illegally; however, the Measure does not authorize or permit otherwise illegal business activity. Monies from the proposed Cannabis Business Tax would be deposited into a special City fund to be used only for police services for public safety, behavioral health and homeless prevention, and intervention programs and services. The amount of the tax would depend on the gross receipts of the business. The tax is imposed on commercial cannabis businesses, and is not a sales tax imposed on qualified patients or primary caregivers.

The Measure sets taxation rates that could be adjusted by the City Council periodically, so long as the rates do not exceed the maximum rates approved by voters. The Cannabis Business Tax would be paid in arrears, on a monthly basis and failure to timely pay would result in certain increasing fines and penalties.

Measure A requires approval by 2/3 of the voters. A "yes" vote for Measure A will establish a Huntington Beach Cannabis Business Tax if commercial cannabis businesses ever become allowed. A "no" vote against Measure A will not establish such a tax.

Exhibit 1 to the City Council Resolution Regarding the Amendment of the Newport Beach City Charter to Provide for the Direct Election of the Mayor by the Voters

SECTION 1: TEXT OF AMENDMENT TO NEWPORT BEACH CITY CHARTER

The City Charter of the City of Newport Beach is hereby amended as follows (underlining showing additions and strikethrough showing deletions):

Section 400. Elective Officers.

The elective officers of the City shall consist of a City Council of <u>six seven</u> members <u>and a Mayor. The term "City Council," "legislative body," or other similar terms as used in this Charter or any other provision of law shall be deemed to refer to the collective body composed of the Mayor and City Council members unless such other provision of this Charter or other provision of law expressly provides to the contrary or unless such interpretation would be clearly contrary to the intent and context of such other provision.</u>

(a) Candidates for City Council shall be nominated from and by the electors of each of the six seven districts referred to in Article X of this Charter and one shall be elected from each of such districts by the voters of the City at large at the times and in the manner provided in this Charter. Ties in voting among candidates for City Council office shall be settled by the casting of lots.

Alternatively, and successively, two four four-year terms (<u>Districts 2 and 5</u>) shall be filled at one the general municipal election occurring in each even-numbered year that is evenly divisible by four and four three four-year terms (<u>Districts 1, 3, 4, and 6</u>) shall be filled at the next such general municipal election occurring in each even-numbered year that is not evenly divisible by four, consistent with the sequence of terms of Council members existing on the effective date of this amendment.

The term of office shall be four years. The term of each City Council member shall commence on the date of the City Council meeting, following his or her election, at which the council receives the certification of election results from the City Clerk.

(b) Candidates for Mayor shall be nominated from and by the electors of the City and elected by the voters of the City at-large at the times and in the manner provided in this Charter. Ties in voting among candidates for Mayor shall be settled by the casting of lots.

The office of Mayor shall be filled at the general municipal election occurring in each even-numbered year that is evenly divisible by four.

The term of office shall be four years. The term of Mayor shall commence on the date of the City Council meeting, following his or her election, at which the Council receives the certification of election results from the City Clerk.

Section 401. Eligibility.

(a) No person shall be eligible to hold office as a member of the City Council unless he or she is, and shall have been for at least thirty (30) days immediately preceding his or her nomination or appointment, a registered elector of the district from which he or she is nominated or appointed, and for at least thirty (30) days immediately preceding his or her election or appointment, a registered elector of the City. No person shall be eligible to hold office as a member of the City Council for a term of office that immediately follows a term to which the person was elected Mayor.

Notwithstanding the provisions of Section 400, no person shall be or remain eligible to hold office as a member of the City Council for more than two (2) consecutive four (4) year terms. Members of the City Council who have served one or more terms prior to their current term shall be entitled to complete such term, but shall not be eligible for re-election except as provided below. Members of the City Council who are serving their first term as of the effective date of this amendment shall be eligible to hold office during a second four year term when the current term expires.

This section is <u>not</u> intended to <u>change the limit on consecutive terms for a member of the City Council enacted by voters in November 1992 prevent persons from serving more than two (2) consecutive terms, and shall not be construed to render ineligible any person who would not, by virtue of his or her election, serve more than two consecutive terms.</u>

(b) No person shall be eligible to hold the office of Mayor unless he or she is, and shall have been for at least thirty (30) days immediately preceding his or her nomination or appointment, a registered elector of the City, and for at least thirty (30) days immediately preceding his or her election or appointment, a registered elector of the City.

Notwithstanding the provisions of Section 400, no person shall be or remain eligible to hold the office of Mayor for more than two (2) four (4) year terms.

This section is intended to prevent persons from serving more than two (2) terms in the office of Mayor, and shall not be construed to render ineligible any person who may have served as a member of the City Council.

Section 403. Vacancies.

A vacancy in the City Council from whatever cause arising, shall be filled by appointment by the City Council of a qualified person from the district in which the vacancy has occurred, such appointee to hold office until the first Tuesday following the next general municipal election and until his or her successor qualifies. At the next general municipal election following any vacancy, a Councilmember shall be elected from the district in which the vacancy exists to serve for the remainder of the unexpired term.

A vacancy in the office of Mayor from whatever cause arising, shall be filled for the remainder of the unexpired term by a special election called by the City Council to be held not less than 88 days nor more than 103 days after the effective date of the vacancy, except the special election may be conducted within 180 days of the effective date of the vacancy in order to consolidate with the City's general municipal election. An election shall not be ordered, and the office of Mayor shall remain vacant, if the term expires within the timeframe for holding a special election.

If a member of the City Council <u>or the Mayor</u> absents himself or herself from all regular meetings of the City Council for a period of sixty days consecutively from and after the last regular City Council meeting attended by such member, unless by permission of the City Council expressed in its official minutes, or is convicted of a crime involving moral turpitude, or ceases to be a qualified elector of his or her district, his or her office shall become vacant and shall be so declared by the City Council.

In the event the City Council shall fail to fill a vacancy by appointment within thirty days after such office shall have been so declared vacant, it shall forthwith cause an election to be held to fill such vacancy from the proper district.

Section **11**

On the date of any meeting of the City Council at which time the Council receives the certification of the results of any general or special municipal election at which any member of Council is elected, the City Council shall, after swearing and qualifying any newly elected member, elect one of its members as its presiding officer, who shall have the title of Mayor.

- (a) The Mayor shall preside at meetings and be a voting member of the City Council, and shall have a voice and vote in all its proceedings.
- (b) Except as provided in Section 405, the Mayor shall have sole discretion to set City Council agendas and to change the order of business on the agendas.
- (c) The Mayor shall have the primary but not exclusive responsibility for interpreting the policies, programs and needs of the City government to the people, and, as occasion requires, the Mayor may inform the people of any change in policy or program.
- (d) The Mayor shall be the official head of the City for ceremonial purposes, and shall perform such other duties consistent with the office as may be prescribed by this Charter or as may be imposed by the City Council. The Mayor shall serve in such capacity at the pleasure of the City Council.
- (e) The City Council shall at the same time the Mayor is elected also designate one of its members as Mayor Pro Tempore, who shall serve in such capacity at the pleasure of the City Council. The Mayor Pro Tempore shall perform the duties of the Mayor during the Mayor's absence or disability.

Section 405. Powers Vested in the City Council.

All powers of the City shall be vested in the City Council except as otherwise provided in this Charter. With the concurrence of at least three members of the City Council at any public meeting, an item may be added to a future City Council agenda.

Section 410. Quorum. Proceedings.

A majority of the members of the City Council shall constitute a quorum to do business but a less number may adjourn from time to time. For purposes of quorum, the Mayor shall be counted as a member of the City Council. In the absence of all the members of the Council from any regular meeting or adjourned regular meeting, the City Clerk may declare the same adjourned to a stated day and hour. Notice of a meeting adjourned by less than a quorum or by the Clerk shall be given by the Clerk or may be waived by consent in the same manner as specified in this Charter for the giving or waiving of notice of special meetings of the City Council; but need not specify the matters to be acted upon. The City Council shall judge the qualifications of its members as set forth by the Charter. It shall judge all election returns. It may establish rules for the conduct of its proceedings and evict or prosecute any member or other person for disorderly conduct at any of its meetings.

Each member of the City Council <u>and the Mayor</u> shall have the power to administer oaths and affirmations in any investigation or proceeding pending before the City Council. The City Council shall have the power and authority to compel the attendance of witnesses, to examine them under oath and to compel the production of evidence before it. Subpoenas shall be issued in the name of the City and be attested by the City Clerk. Disobedience of such subpoenas, or the refusal to testify (upon other than constitutional grounds), shall constitute a misdemeanor, and shall be punishable in the same manner as violations of this Charter are punishable.

At the demand of any member, the City Clerk shall call the roll and shall cause the ayes and nays taken on an issue which is the subject of the demand to be entered in the minutes of the meeting.

Section 1004. Voters Signing Nomination Petitions.

The voters signing any petition for the nomination of any person to the office of Councilmember shall be residents and registered voters of the district from which such person is to be nominated.

The voters signing any petition for the nomination of any person to the office of Mayor shall be residents and registered voters of the City.

Section 1005. Districts.

The City is hereby divided into <u>six</u> seven districts, the names and respective boundaries of which shall be as established by ordinance. No ordinance changing and redefining the boundaries of any district shall be enacted within six months prior to any regular Councilmanic election.

Following the national census and each tenth year thereafter the City Council shall appoint a committee to study and report to the City Council on the advisability of redistricting the City. Upon receipt of any such committee report, and at any other time deemed necessary or desirable in order that the district boundaries be fair and logical, the City Council may by ordinance change and redefine the boundaries of any or all of the six seven districts herein established. The boundaries so defined shall be established in such manner that the districts shall, as nearly as practicable, constitute natural areas of contiguous and compact territory and provide fair representation on the City Council. Notwithstanding the provisions of Section 401, no redistricting shall disqualify any Councilmember from serving as Councilmember from the district from which he or her was nominated or appointed for the remainder of his or her term, if elected, or until the next general municipal election, if appointed. Any territory hereafter annexed to or consolidated with the City shall, at the time of such annexation or consolidation, be added by ordinance of the City Council to an adjacent district or districts.

SECTION 2: BALLOT DESCRIPTION

As provided in Government Code section 34458.5, the following ballot description is included in this proposed Charter Amendment measure:

CHARTER AMENDMENTS

DIRECT ELECTION OF MAYOR – The proposed Charter Amendment measure would amend Newport Beach City Charter Sections 400, 401, 1004, and 1005 to change the composition of the City Council from seven Council Members to a Mayor and six Council Members. The Mayor would be nominated by residents and registered voters of the City of Newport Beach ("City") and elected by the voters of the City at-large. The number of City Council districts would be reduced to six and the Council Members would be elected from each of the six districts by the City electors at-large. The person elected Mayor would serve a term of four years and would only be eligible to hold the office of Mayor for two four-year terms in the person's lifetime. Also, the Mayor would be ineligible to hold office as a Councilmember for the term of office that immediately follows a term to which the person was elected Mayor. This measure would also amend Charter Section 403 to provide a procedure for filing a vacancy in the office of Mayor.

a quorum to conduct business; preside at all Council meetings, be a voting member of the Council, have the discretion to determine the order of business and have a voice in all Council proceedings; and set Council meeting agendas; however, at any Council meeting, three Councilmembers would have the discretion to add an item to a future agenda. This Charter Amendment does not give the City Council power to raise its own compensation or the compensation of other City officials without voter approval.

SECTION 3: SEVERABILITY

It is the intent of the people that the provisions of this Charter Amendment measure are severable and that if any provision of this Charter Amendment measure, or the application thereof to any person or circumstance, is held invalid such invalidity shall not affect any other provision or application of this Charter Amendment measure which can be given effect without the invalid provision or application.

SECTION 4: CONFLICTING MEASURES

In the event this Charter Amendment measure and another measure or measures relating to establishing the office of elected Mayor, City Council districts, and term limits for the Mayor, the other matters described herein shall appear on the same special municipal election ballot, the other Charter measure or measures shall be deemed to be in conflict with this Charter Amendment measure. In the event that this Charter Amendment measure receives a greater number of affirmative votes, the provisions of this measure shall prevail in their entirety, and the provisions of the other measure or measures shall be null and void.

If this Charter Amendment measure is approved by the voters but superseded in whole or in part by any other conflicting measure approved by the voters at the same election, and such other conflicting measure is later found held invalid, this measure shall be self-executing and given full force and effect.

SECTION 5: IMPLEMENTATION

In the event this Charter Amendment measure is approved:

- A. The members of the City Council in office at the time these Charter provisions take effect shall continue in office until the expiration of their respective terms and until their successors are elected and qualified.
- B. The City Council shall, no later than six (6) months prior to the next general municipal election held after the year in which the Charter amendments adopted herein take effect, follow any process required by applicable law and adopt an ordinance to establish the respective boundaries of the six (6) City Council districts.
- C. The enactment of this measure shall not be interpreted or applied to reset or extend the limit on consecutive terms applicable to any person holding office as a member of the City Council at the time this measure is approved by voters.

SECTION 6: EFFECTIVE DATE

This Charter Amendment measure shall become effective in the manner allowed by law.

Impartial Analysis City of Newport Beach Measure B

This measure was placed on the ballot by the City of Newport Beach ("City") City Council ("Council") pursuant to the authority provided by Section 3 of Article XI of the California Constitution, Section 1001 of the City Charter ("Charter"), and Sections 1415 (a)(2) and 9255(b)(1) of the California Elections Code. This City-sponsored measure would amend the Charter to provide for the direct election of the Mayor by the voters of the City at-large, instead of the Council electing one of its members to be Mayor. The person elected Mayor would serve a term of four years; only be eligible to hold the office of Mayor for two four-year terms in the person's lifetime; and be ineligible to hold office as a Councilmember for the term of office immediately following the term to which the person was elected Mayor.

Currently, one Councilmember is elected from each of the seven Council districts ("Districts") by the City electors at-large. This measure proposes to reduce the number of Districts to six, with election of the Mayor and Districts two and five being filled at the general municipal election occurring in each even-numbered year that is evenly divisible by four; and Districts one, three, four, and six being filled at the general municipal election occurring in each even-numbered year that is not evenly divisible by four. Councilmembers would still be elected from each of the six Districts by the City electors at-large. The six new District boundaries would be established at least six months prior to the general municipal election in 2024.

This measure proposes to have the Mayor preside at Council meetings, be a voting member of the Council, and have a voice in Council proceedings. Also, the Mayor would be counted as a Councilmember for purposes of establishing quorum to conduct business at Council meetings. The Mayor would be primarily responsible for setting Council meeting agendas; however, at any Council meeting, three Councilmembers would have the discretion to add an item to a future agenda. In addition, the measure provides procedures to fill the office of Mayor if the position becomes vacant.

This measure would not reset or extend existing term limits applicable to Councilmembers.

This proposed City-sponsored measure requires approval of a majority of voters. A "yes" vote is a vote in favor of amending the Charter to provide for the direct election of the Mayor. A "no" vote will reject the proposed amendment to the Charter, leaving the Charter in its present form.

The proponents don't mention passage of Measure B would not only provide for direct election of the mayor, but would add dangerous new powers the Newport Beach mayor currently doesn't have, including near complete control over the council agenda's content.

They claim their proposal would make city government more responsive when in actuality it would be less: one of the six city council districts will be represented by both a mayor and a council person, giving one district greater decision-making authority. ORDINANCE NO. XXXX

AN ORDINANCE OF THE PEOPLE OF THE CITY OF WESTMINSTER, AMENDING CHAPTER 2.04 ("CITY COUNCIL") OF THE WESTMINSTER MUNICIPAL CODE ELIMINATING THE OFFICE OF ELECTED MAYOR

WHEREAS, the electors from within the City of Westminster currently directly elect a mayor via an "at large" voting process; and

WHEREAS, the electors from within City of Westminster also currently elect four councilmembers from four separate districts in the City; and

WHEREAS, Government Code Section 34902(b) authorizes the City Council to submit to the voters the question of whether to eliminate the elective office of mayor and "reestablish the procedure of selection of the mayor by the city council"; and

WHEREAS, the City Council desires to submit to the voters the question of whether to adopt an ordinance eliminating the office of elected mayor and electing five city councilmembers from five separate districts; and

WHEREAS, this ordinance not a "project" as defined in 14 CCR 15378 of the Guidelines to the California Environmental Quality Act ("CEQA") because this is an "organizational or administrative activity that will not result in direct or indirect physical changes in the environment;

WHEREAS, even if this ordinance were a "project" under CEQA, there is no possibility that the adoption of this ordinance will have a significant impact on the environment, because this ordinance will not lead to construction or any other change in the environment. Therefore, the adoption of this ordinance is exempt from the California Environmental Quality Act ("CEQA"), pursuant to Section 15061(b)(3) of the CEQA Guidelines (Title 14, Chapter 3 of the California Code of Regulations).

NOW THEREFORE, THE PEOPLE OF THE CITY OF WESTMINSTER DO HEREBY ORDAIN AS FOLLOWS:

SECTION 1. Salaries.

Section 2.04.080 of the Westminster Municipal Code is hereby amended to provide as follows:

2.04.080 Salaries.

Pursuant to California Government Code Section 36516 and this section of the Westminster Municipal Code, the city council of the city of Westminster hereby establishes councilmember compensation in the amount of eight hundred fifty dollars and fifty cents per month for each councilmember, effective upon the commencement of a new term of office by any councilmember.

SECTION 2. Organization.

Section 2.04.090 of the Westminster Municipal Code is hereby amended to provide as follows:

2.04.090 Organization.

- (a) MAYOR. At the meeting at which the City Council approves the certification of election results following any general election at which members of the City Council are elected, and at the first meeting in December during any non-election year, or at any time when there is a vacancy in the office of Mayor, the City Council shall meet and shall elect one of its members as its presiding officer, who shall have the Title of Mayor. The Mayor shall have a voice and vote in all City Council proceedings. The Mayor shall be the official head of the City for all purposes including ceremonial. The Mayor shall perform such other duties as may be prescribed by this municipal code or as may be imposed by the City Council consistent with the office. The Mayor shall serve in such capacity at the pleasure of the City Council.
- (b) VICE MAYOR. At the same meeting when a Mayor is selected, the City Council shall also designate one of its members as Vice Mayor who shall serve in such capacity at the pleasure of the City Council. The Vice Mayor shall perform the duties of the Mayor during any absence or disability of the Mayor.

SECTION 3. Terms of Office.

Section 2.04.100 of the Westminster Municipal Code is hereby amended to provide as follows:

2.04.100 Terms of office for city councilmembers.

The general municipal election for all elected city officers shall be consolidated with the statewide general election on the first Tuesday after the first Monday of November in each even-numbered year. There shall be five elected councilmembers from five separate districts in the city, who shall each serve a four-year term.

SECTION 4. By-district elections.

Section 2.04.120 of the Westminster Municipal Code is hereby amended to provide as follows:

2.04.120 By-district elections.

- A. City Council. The <u>five</u> elected council members shall be elected by district at the times and in the manner provided in this chapter, in a sequence to be determined by ordinance.
- B. Residency in Districts. Each member of the city council must be a resident of the council district from which the member is nominated at the time the member is nominated, elected, and throughout that member's term of office. In the event any member of the city council ceases to be a resident of the district from which the member (or, in the case of an appointee, a predecessor) was nominated, the office shall immediately become vacant and shall be filled in the same manner as herein provided for other vacancies. If a member of the city council ceases to be a resident of the district from which the member (or, in the case of an appointee, a predecessor) was nominated solely because of a change in the boundaries as provided herein, the member shall not lose office during that term by reason of such change.



Sectio **11**

- C. Council Districts. The city is hereby divided into five districts, as set forth herein. Candidates for council seats in each district shall be nominated and elected only by the voters of that district and shall reside in that district.
- D. District Boundaries. The boundaries of the council member districts of the city shall be established in the manner required by Government Code Section 34877.5 and California Elections Code Section 10010.
- E. Changes in Boundaries. The boundaries of said city council districts may be changed by ordinance adopted by the city council by three-fifths vote of all its members; provided that districts must be established in accordance with applicable law. See Elections Code 21601. Boundaries shall be adjusted by the city council as required by law following each decennial federal census, or as otherwise authorized by law. After city council has exercised its power to change the boundaries of districts, these changes shall immediately be reflected in the district boundaries specified by ordinance adopted by the city council.
- F. Current Officeholders. The mayor and four members of the city council in office at the time this section takes effect shall continue in office until their existing terms expire.
- G. Council Elections Sequenced. The members of the Council of the first, fourth and fifth districts shall be elected commencing in the year 2022 to the Council seats then open, and in each fourth year thereafter. The members of the Council of the second and third districts shall be elected commencing in the year 2024 to the Council seats then open, and in each fourth year thereafter.

SECTION 5. Term Limits.

Section 2.04.125 ("Term limits") of the Westminster Municipal Code is hereby amended to provide as follows:

2.04.125 Term limits.

- A. No person shall be eligible to serve in the office of city council member for more than three four-year terms following the adoption of this measure, commencing with those elected in the November 3, 2020 election.
- B. Notwithstanding the foregoing and for the purpose of term limitation, any person who is appointed by the city council or elected to fill a vacant office of a city council member for an unexpired term of more than one-half the original term shall be deemed to have served a full term.

SECTION 6. Future Amendments.

Nothing in this ordinance is intended to prevent the City Council from subsequently adopting ordinances which directly amend those sections amended by this ordinance, provided that such amendments do not change the fact that the mayor is not to be directly elected, and the five councilmembers are to be elected from five districts. Further, nothing in this ordinance is intended to prohibit the City Council from taking any action, including the adoption of subsequent ordinances, to further the purposes of this ordinance.

<u>SECTION 7. Interpretation</u>. Nothing in this ordinance is intended to directly affect the position of directly elected mayor until the current Mayor's term of office expires.

SECTION 8.Severability.

If any section, subsection, clause or phrase or portion of this code is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of all other provisions of this ordinance.

SECTION 9. Effective Date.

This Ordinance shall take immediate effect upon approval by a majority of the voters voting at the special municipal election to be held June 7, 2022.



Section 11

Impartial Analysis City of Westminster Measure C

The Westminster City Council is currently comprised of four councilmembers and a mayor, each of whom serve four-year terms. Each councilmember represents a geographic district and is elected by the voters of that district. The mayor is elected at-large (by all of the voters of the City). The mayor serves as chair of the City Council, is a voting member of the City Council, and performs certain ceremonial and ministerial functions (such as signing ordinances and resolutions adopted by the City Council). The mayor does not have a veto power.

Measure C is an ordinance placed on the ballot by the City Council. If the ordinance is adopted by a majority of Westminster voters, the number of councilmembers would be expanded to five and the at-large mayor office would be eliminated. The five councilmembers would then select one member to serve as mayor. The mayor would, in addition to his or her duties as a councilmember, chair the City Council, perform certain ceremonial and ministerial functions as the official head of the City, and perform other duties assigned by the Municipal Code or the City Council. The mayor would not have a veto power, and could be removed from the position of mayor by a vote of the City Council.

Councilmember terms are staggered, so that all seats are not up for election at the same time. Two of the current councilmembers (representing Districts 2 and 3) were elected in 2020, so regardless of whether this measure passes, their seats will not be on the ballot until 2024.

If this measure does not pass, then two councilmember seats (Districts 1 and 4) and the at-large mayor office will appear on the November 2022 ballot to be filled. However, if this measure passes then three councilmember seats will appear on the November 2022 ballot (Districts 1, 4 and the new District 5). This measure would not shorten the term of the currently elected mayor, whose term will end when the November 2022 election is certified.

As of the date this analysis was prepared in February 2022, the City Council was in the process of adopting district maps for both a four-district council and a five-district council. These maps were expected to be fully adopted no later than April 17, 2022. If this measure is not adopted, then the four-district map would be used in the November 2022 election. If this measure is adopted, then the five-district map would be used instead.

A "yes" vote is a vote to eliminate the office of elected mayor, and to instead cause the City Council to be comprised of five councilmembers elected from five geographic districts. A "no" vote is a vote to retain the current structure, with an at-large elected mayor and four councilmembers elected from geographic districts.

- Westminster has had only <u>two</u> mayors in <u>22</u> years!
- Westminster did <u>not</u> have a directly-elected mayor until 1986. This
 measure merely reestablishes the original procedure of selecting a
 mayor annually as it was before 1986.
- Only <u>seven</u> cities in Orange County have a directly-elected mayor, all but one have significantly larger populations than Westminster.
