We have determined that **the signature you provided on your vote-by-mail ballot envelope does not compare with the signature(s) on file in your voter record.** In order for your vote-by-mail ballot to be eligible to be counted, the enclosed Signature Verification Statement must be completed and received by the Registrar of Voters by 5:00 p.m., October 16, 2023, which will ensure it is received at least two days prior to the date the Registrar of Voters certifies the results of this election. California Elections Code §3019(d)(4).

To meet the statutory deadline, you are encouraged to deliver the Signature Verification Statement to the Registrar of Voters by any of the methods indicated below by 5:00 p.m. on October 16, 2023.

You must sign your name on the **Signature Verification Statement** below. Return the Signature Verification Statement in the included postage-paid Business Reply Mail envelope using one of the following methods:

- **Mail:** Use the postage-paid envelope included or mail to Orange County Registrar of Voters, 1300 S. Grand Ave, Bldg C, Santa Ana, CA 92705
