Notice is hereby given that an election will be held in the County of Orange on November 5, 2024, for the purpose of electing governing board members/directors for the following districts:

To qualify for office, a candidate shall be a registered voter in the district and, if applicable, in the trustee area/division.

Appointment to each elective office will be made, as prescribed by California Elections Code Section 10515, in the event there are no nominees or an insufficient number of nominees for such office and a petition for an election is not filed within the time period prescribed by said Section 10515.

Notice is further given that all ballots cast will be counted centrally at the Orange County Registrar of Voters, 1300 South Grand Avenue, Building C, Santa Ana.
