IMPARTIAL ANALYSIS BY CITY ATTORNEY MEASURE D

(Sections 401, 401.05)

Measure D makes changes to the Santa Ana Charter regarding City Council term limits and adds a provision to the Charter calling for the adoption of a Code of Ethics and Conduct governing members of the City Council and the City's boards, commissions and committees.

First, Measure D amends Section 401 of the Charter to change the term limits of city councilmembers from two terms to three terms.

Second, Measure D adds a new Section 401.05 to the Charter which directs the City Council to adopt a Code of Ethics and Conduct with the stated goal of assuring public confidence in the integrity of local government elected and appointed officials. Section 401.05 directs that these new standards be adopted within six months of the effective date of this Charter amendment. If Measure D is approved, the amendments would be in effect for the November 2008 General Election. THE ABOVE STATEMENT IS AN IMPARTIAL ANALYSIS OF MEASURE D. In fact, the Santa Ana Charter Review Commission RECOMMENDED mayoral term limits. But the majority of our City Council has IGNORED their findings – and CONTINUES to do so.

Last year, Santa Ana Councilmembers Mike Garcia, Jose Solorio, and Carlos Bustamante, supported Measure BB, which prohibited termed-out Councilmembers from running again for 8 years. They said that "it is important to create opportunities for new leadership in the City of Santa Ana. Recycling the same leadership on the City Council is not in the best interests of the city."
