Proof of publication must be provided to the Registrar of Voters prior to circulation. <u>June 7<sup>th</sup> is the last day for the 180-day period to begin if proponents wish to have the entire 180-day period for publication of Notice of Intention/County Counsel's Ballot Title and Summary and for circulation of the petition.</u></b> §§ 9105(b), 9108, 9110</p> <p>Last day for initiative proponents to file 72,802 (10%) or 145,604 (20%) valid signatures with the Registrar of Voters. § 9107</p> <p>Last day for Registrar of Voters to verify petition signatures in order to place on ballot. § 9114</p>

March 12, 2010* (E-88)	County Counsel's Impartial Analysis and any Fiscal Impact Statements to be printed in the sample ballot pamphlet are due to Registrar of Voters. Last day for Direct Arguments to be filed with Registrar of Voters. §§ 9160, 9162, 9163
March 13, 2010 through March 22, 2010 (E-87 – 78)	Public Review period begins on March 13, 2010 and closes March 22, 2010, 5:00 p.m. All documents that will be subject to public review will be posted on the Registrar of Voters website and available at the Registrar of Voters office on Monday through Friday, 8:00 a.m. to 5:00 p.m. Direct Arguments, Impartial Analysis and Fiscal Impact Statements are subject to legal action during this public review period. § 9190
March 22, 2010 (E-78)	Deadline for submittal of Rebuttal Arguments to be filed with Registrar of Voters. § 9167
March 23, 2010 through April 1, 2010 (E-77 – 68)	Public Review period for Rebuttal Arguments begins on March 23, 2010 and closes April 1, 2010. The Rebuttal Arguments will be posted on the Registrar of Voters website and available at the Registrar of Voters office on Monday through Friday, 8:00 a.m. to 5:00 p.m. Only Rebuttal Arguments are subject to legal action during this public review period. § 9190
April 29, 2010 (E-40)	Registrar of Voters begins sample ballot mailing approximately on this date. Mailing completed no later than May 29, 2010. § 13300
